This group will be essential in ensuring all stakeholder groups have a voice and the opportunity to be involved in this long-term planning process.

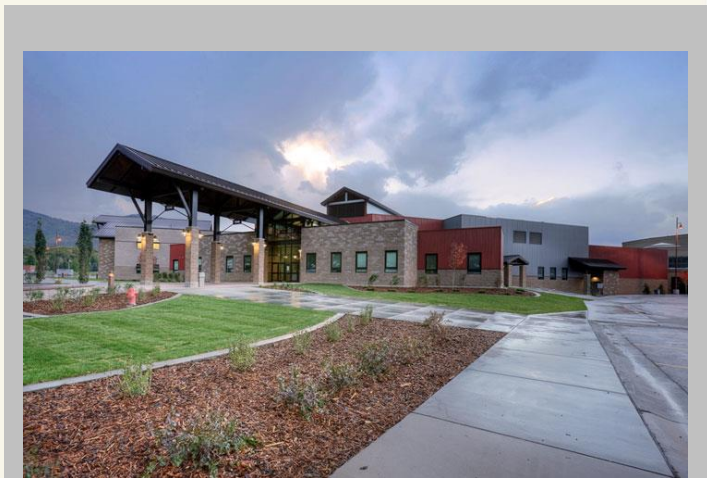

RESPONSIBILITIES

- Long-term commitment, approximately 8 months
- Attend meetings (typically during early evenings)
- Work in a collaborative environment with multiple other stakeholders and experts
- Provide feedback to questions proposed by the design team and District
- Represent your stakeholder group and be willing and able to communicate feedback and updates to other members outside of the committee within your stakeholder group
- Do a little homework (we may ask you to think about an issue or question and bring your thoughts to the next meeting)

OTHER INFO

- On average meetings will be held bi-weekly to monthly but may vary in frequency depending on the stage of the planning process.
- Meetings will start in August 2018 and continue through April 2019
- Meetings will vary from 1-3 hours in duration.
- The first meeting will take place in August 2018. A final date and location is to be determined.
- Committee size will be determined by responses received and we may not be able to accommodate all interested parties due to size limitations.
